- 5. Hamilton Police Services Update Sgt. Alex Buck Indicated that the crime trends for 2024 are consistent with the average from last year at the same time. Shared that trespassing, ambulance assist and suspicious activity are the three most frequent calls for service within the entirety of Ward 2.
- 6. Councillor Update Councillor Cameron Kroetsch
  - a. Public Washrooms
  - b. Core Patrol Priorities

Began by discussing a council motion to bring temporary public washrooms to downtown parks. Noted that if a temporary washroom was to be placed in Gore Park, its continued maintenance would not be the responsibility of the BIA or its staff. Then proceeded to discuss the City of Hamilton's encampment protocol and its purpose, before ending by clarifying the relationship between the City Council and the Hamilton Police Service. Downtown Hamilton BIA members Paula and Michael Cipollo were then recognized by the Chair and discussed the topic of safety and the perception of the area within the Downtown Hamilton BIA.
