- 1. Welcome and comments from the Chair Evan welcomed everyone
- 2. Declaration of Conflicts of Interest L. LaRocca indicated a conflict of interest regarding a potential Supercrawl sponsorship included in the staff update
- 3. Agenda MOTION: That the agenda be approved as presented. Moved by M. Blanchard, Seconded by U. Gibbons CARRIED
- 4. Approval of Minutes **MOTION**: That the minutes of January 28, 2025 be approved as presented. **Moved by U. Gibbons, Seconded by M. Blanchard CARRIED**
- 5. Board Vacancy Appointment MOTION: That Graziella Panessa be appointed to the Downtown Hamilton BIA Board of Management, pending approval by City Council. Moved by E. Apostol, Seconded by M. Blanchard CARRIED
- 6. City of Hamilton Update Councillor Cameron Kroetsch shared details about the current status of a variety of future initiatives that are relevant to the downtown core, including enhanced bylaw enforcement, enhanced cleanliness initiatives and increased social service supports. He then quickly discussed Gore Park, sharing updates about a potential closure and how community groups use the park.
- 7. Hamilton Police Services Update A/Sgt. Kenneth Kaija shared crime statistics from the month of February, acknowledging that a majority of the instances came from Jackson Square, which is not included in the Downtown Hamilton BIA's boundary. He then spoke about the ongoing core patrol,

Sarah spoke about the goals and approaches for placemaking across the city in 2025, including some current projects and potential future projects.

- 10. Other Items BIA Staff Update Emily Walsh shared information about a variety of topics relevant to the Downtown Hamilton BIA, including an update on proposed changes to on-street parking rates, LRT updates, a Valentine's Day giveaway that the BIA ran and more.
